The Board of Commissioners (the "Board") of the County of Davidson, North Carolina (the "County") is considering (1) entering into an installment financing contract in an amount not to exceed \$32,000,000 (the "Contract") to finance the acquisition, construction and equipping of (a) the renovation of and addition to the existing County courthouse facility (the "Courthouse") and (b) improvements to certain public school facilities (collectively, the "Project") and (2) executing and delivering a deed of trust, security agreement and fixture filing (the "Deed of Trust") related to the County's fee simple interest in the Courthouse, together with the improvements thereon (collectively, the "Mortgaged Property"), as may be required by the entity providing the funds to the County under the Contract. The Courthouse is located at 110 West Center Street, Lexington, North Carolina.
