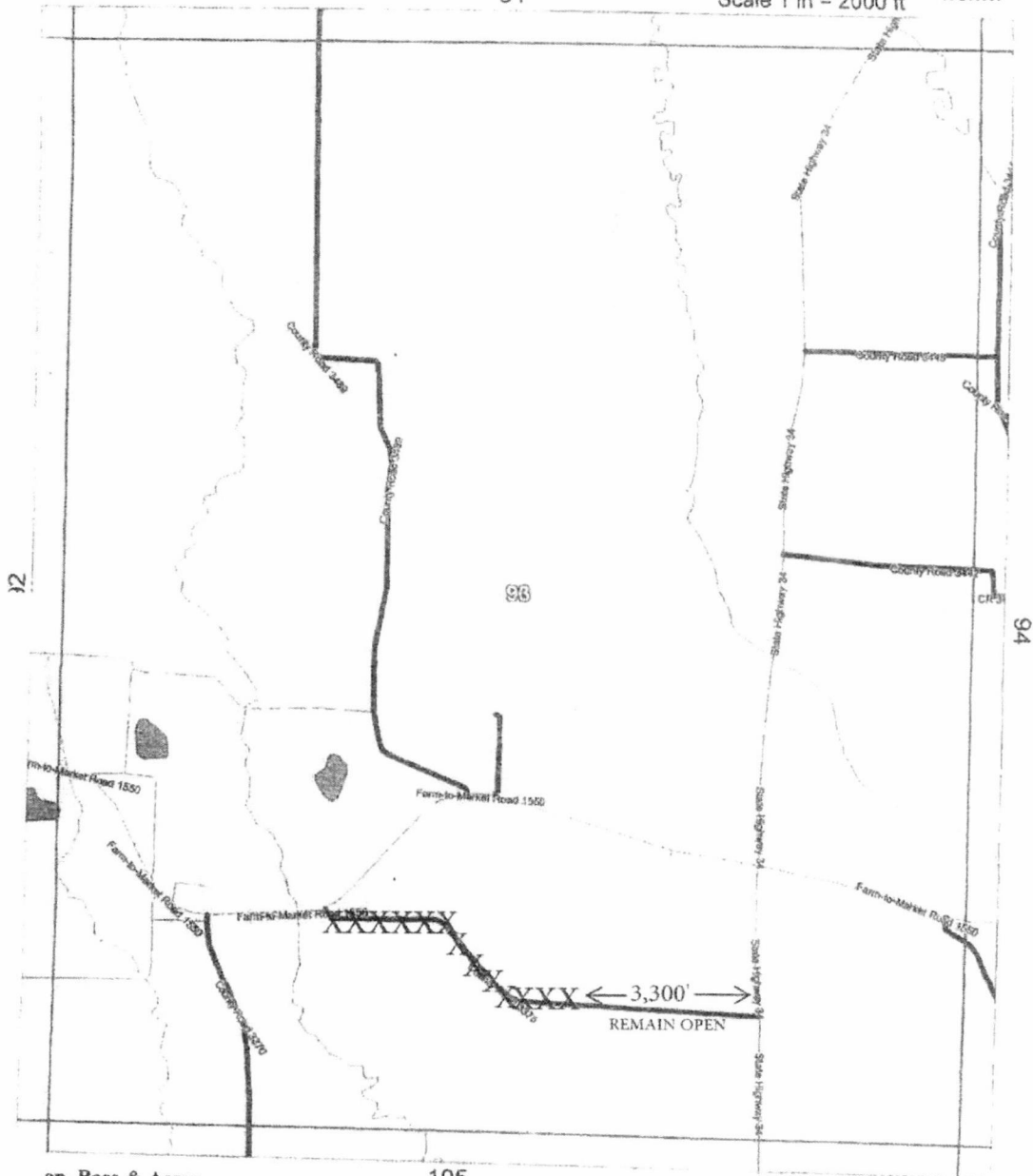
County Maintained Road
