A Resolution to Direct Staff to Pursue a Prompt Settlement of the Current Labor Dispute with City Employees LIUNA Local 363

The Minneapolis Park and Recreation Board ("MPRB") adopts this Resolution to pursue a prompt settlement of the current labor dispute with City Employees LIUNA Local 363 ("Union").

Whereas, the MPRB intends to enter into a fair agreement that reflects the significant value our employees bring to Minneapolis' award-winning, nationally recognized park system; and

Whereas, the MPRB recognizes the work done by Superintendent Al Bangoura and MPRB staff to bargain, keeping the long-term future of our parks in mind; and

Whereas, the MPRB values the critical work performed by the members of the Union in maintaining and improving the parks and recreational facilities that have been ranked among the best in the nation; and

Whereas, the MPRB was established in 1883 by an act of the Minnesota State Legislature and this is the first worker strike in its 141-year history; and

Whereas, the labor-management conflict that is currently taking place distracts from fulfillment of our important mission of preserving, protecting, maintaining, improving, and enhancing our park system; and

Whereas, it is in the best interest of the MPRB, its employees, and the residents of Minneapolis to prioritize focusing on the fulfillment of our mission and reaching a fair and reasonable resolution to this contract dispute immediately;

Now Therefore, Be it Resolved, that the Minneapolis Park and Recreation Board hereby directs its staff to promptly make a proposal to the Union that meets the following criteria:

1. Includes the schedule of wages increases and market adjustment increases that the MPRB proposed in its Final Offer of Settlement and which the Union has expressed its willingness to accept.
2. Includes all items that the MPRB and the Union have tentatively agreed upon.
3. Does not include any other proposals that were not tentatively agreed upon.
