**WHEREAS**, on July 12, 2022, the Board of Supervisors of the County of Yuba adopted Resolution number 2022-188 formally adopting the Classification System – Basic Salary / Hourly Schedule effective July 1, 2022; and

**WHEREAS**, the Treasurer – Tax Collector requested an organizational assessment of office operations to ensure the allocated classifications were appropriately classified; and

**WHEREAS**, the County Administrator's Office and Human Resources Department supported the request and the Human Resources Department contracted with Bryce Consultants to complete the organizational assessment; and

**WHEREAS**, the consultant found most classifications to be appropriately classified in the Treasurer – Tax Collector's Office with the exception of the supervisory class; and

**WHEREAS**, the consultant found the level, scope, and criticality of the treasury and tax collection functions performed by the incumbent to be consistent with a mid-management classification and recommended a Treasury and Tax Manager class be created with a base salary commensurate with the County's internal compensation structure; and

**WHEREAS**, the Human Resources Department concurs with the recommendation to create a Treasury and Tax Manager class and subsequently delete the existing mid-management class of Chief Deputy Treasurer / Tax Collector class which has not been used in over six years; and

**WHEREAS**, the Board of Supervisors now intends to amend Resolution No. 2022-188 as it relates to the Classification System – Basic Salary/Hourly Schedule to add the new classification of Treasury and Tax Manager with a base salary consistent with

internal comparable data and delete the class of Chief Deputy Treasurer / Tax Collector, effective November 1, 2021.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the County of Yuba, that Resolution number 2022-188 be and hereby is amended as it relates to the Treasury and Tax Manager and Chief Deputy Treasurer / Tax Collector classifications.

**BE IT FURTHER RESOLVED**, the Classification System – Basic Salary / Hourly Schedule as documented in Attachment A, attached hereto and incorporated herein by reference as though fully set forth, is hereby established and effective November 1, 2022.
