*WHEREAS*, the County of Yuba participates in the Public Defense Pilot Program (“Program”) funded through the State Budget Act of 2021 (Senate Bill 129) which is administered by the Board of State and Community Corrections (“the BSCC”);

*WHEREAS*, the County of Yuba was awarded Public Defense Pilot Program initial grant funds by the BSCC in 2022;

*WHEREAS*, the current public defender contract for the County of Yuba is held by Brian J. Davis; and

*WHEREAS*, in or about 2022 Brian J. Davis developed and implemented “Project Second Chance” with the initial funding from the Program to provide representation to those individuals meeting the criteria for consideration under the Program;

*WHEREAS* the County of Yuba was invited by the BSCC to apply for Year 2 funding from the Public Defense Pilot Program;

*WHEREAS* Brian J. Davis wishes to continue to receive grant funding to further implement and develop Project Second Chance with Year 2 funds from the Program;

*NOW, THEREFORE, BE IT RESOLVED*, that the Yuba County Board of Supervisors authorizes Brian J. Davis on behalf of the Yuba County Board of Supervisors to sign and submit the State of California Department of General Services Standard Agreement Number BSCC 355-21, Amendment Number 1 for Year 2 funding from the Public Defense Pilot Program administered by the BSCC.

**BE IT FURTHER RESOLVED**, that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

**BE IT FURTHER RESOLVED** that the County of Yuba agrees to abide by the terms and conditions of the Grant Agreement as set forth by BSCC.

**BE IT FURTHER RESOLVED** that Yuba County Administrator, or his designee, are granted authority to sign subsequent grant applications to continue to receive funding in subsequent years from the Public Defense Pilot Program administered through the BSCC.
